## SOURCE PROTECTION AREA EASEMENT

**WHEREAS**, Broken Box C LLC, a Washington limited liability company, Grantor, is the owner of the property described in attached Exhibit "A"; and

**WHEREAS**, Chilton Inc., a Washington corporation, Grantee, is the owner of the property described in attached Exhibit "B"; and

**WHEREAS**, there is an existing well (**BQS614**) to serve Grantee's property as a shared well; and

**WHEREAS**, the undersigned parties wish to establish a source protection area easement extending one-hundred (100) feet in diameter of the well described in attached Exhibit "C".

The easement created hereby shall run with the land, and the parties herein agree that they will not construct, maintain, or suffer to be constructed or maintained upon the said land and within one-hundred (100) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any of the following: cesspools, sewers, privies, septic tanks, drainfields, manure piles, garbage of any kind or description, barns, chicken houses, rabbit hutches, pigpens, or other enclosures or structures for the keeping or maintenance of fowls or animals, or storage of liquid or dry chemicals, herbicides, or insecticides.

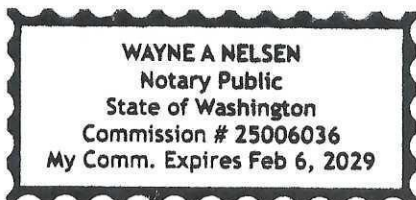

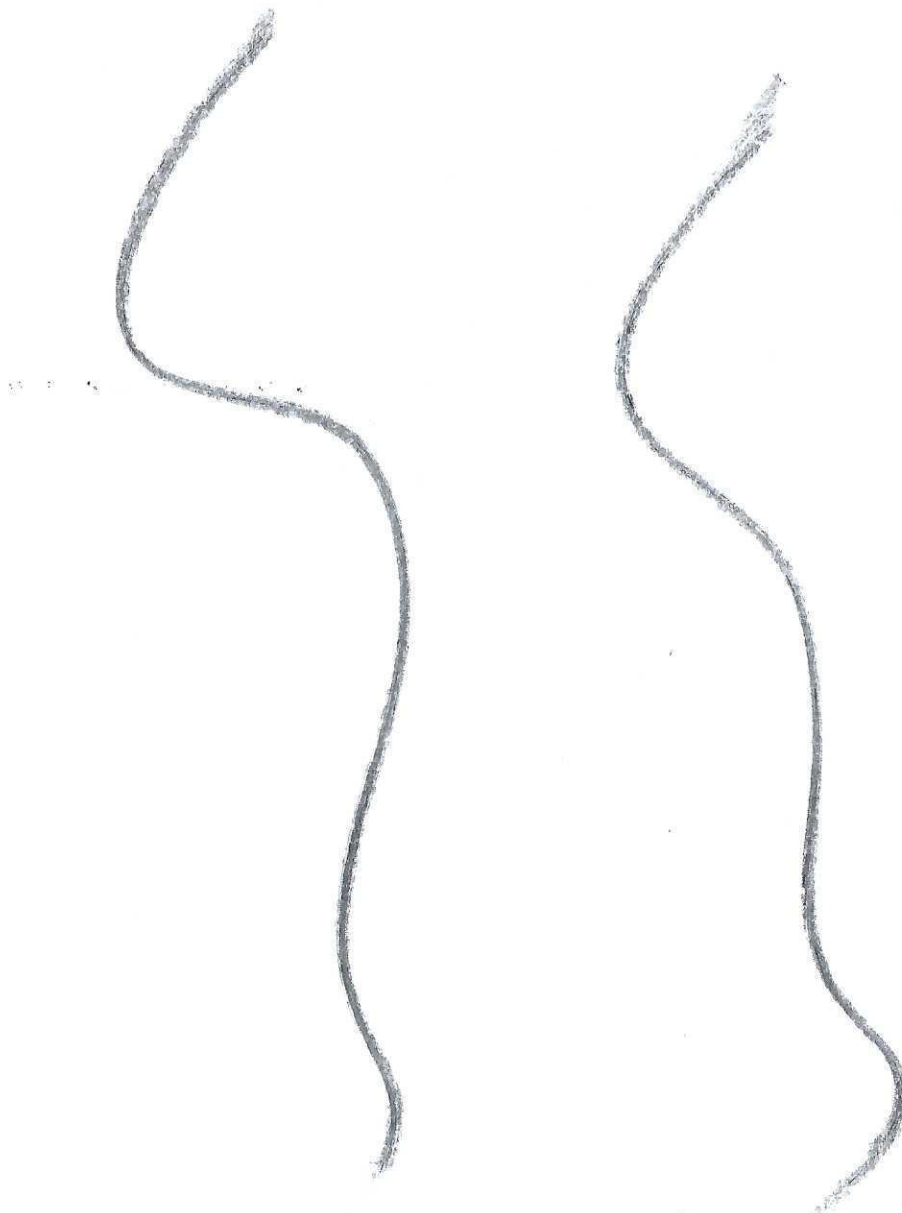

COWLITZ COUNTY, WA.

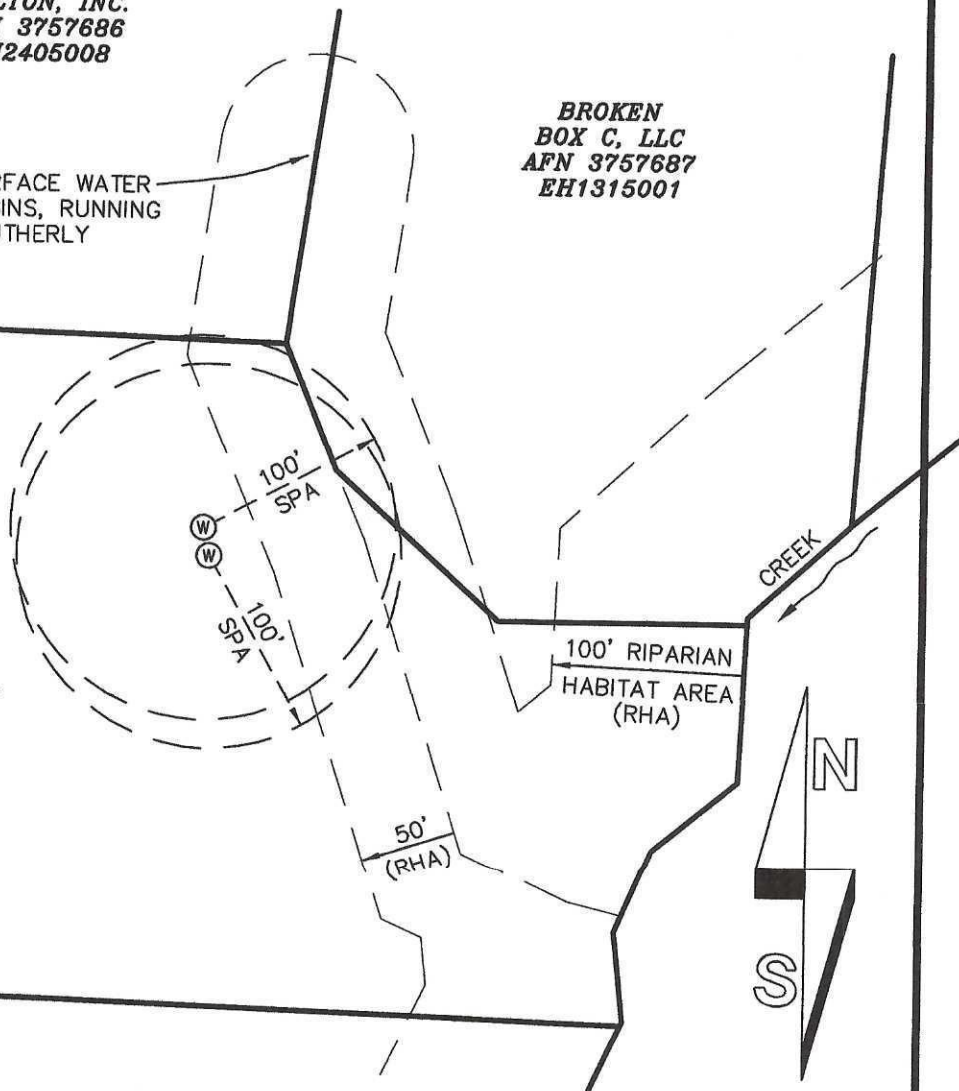
